July 1, 2006









Contestant vying for a state title must be a U.S. citizen. International contestants must have proof of

citizenship of country she represents

Contestant must be single, never have been married, nor given birth to a child.

Contestant must be of good health & moral character.

Contestant must never have been convicted of a felony crime.





































Contestant must never have nor will she during her reign pose for any photography, video or film associated

Contestant will be subject to a sponsor fee, which may vary from state with each state or country.

A contestant may be selected to participate as a delegate "at-large" if there is no competition in

her state or country

with nudity or pornography. Nor has she ever or is presently involved with any type of employment

involving partial or full nudity.

Any contestant and/or family member or guest showing less than sportsman like behavior will lead to

the disqualification of the contestant. No refund will be given under these circumstances.











Contestant will permit Miss Teen International and their licensees to televise live or by use of film or videotape

any portion or all of the competition.

Contestant agrees to abide by all rules and regulations of the Regional, State and International competitions.
